Gas Grills Usage Policy

PROCEDURE TITLE: Gas Grill Usage Policy

PROCEDURE NO.: 7000-02

EFFECTIVE DATE: October 21, 2014

Policy:

The Village of Mannville loans flat topped gas powered grills for public use, as a service to the community at large. Anyone requesting the use of a grill must read this policy and agree to its terms and conditions prior to use. Only individuals who have read and signed this policy may use the grill. At least two (2) people must be designated as authorized users to ensure that the grill is not left unattended.

Procedures:

- 1. Individuals who wish to use the grill must have read and understand all directions for use.
- 2. Only individuals sixteen (16) years of age or older are permitted to use the grill.
- 3. All visitors and unapproved users must remain two (2) meters away from the grill at all times.
- 4. There should be no more than three (3) people around the grill at any one time (anyone near the grill must have read and agreed to this policy).
- 5. Food cooked on the grill must be put on a serving tray or plate and brought away from the grill when served in order to limit the number of people in the vicinity of the grill.
- 6. The grill cannot be left unattended while lit or while it is still hot.
- 7. Intoxicated individuals are strictly prohibited from using the grill.
- 8. No smoking is permitted near the gas grill at any time.
- 9. When using the grill, a fire suppression tool (e.g. fire extinguisher) must be available.

Responsibilities:

- 1. The grill must be used outdoors.
- 2. The grill should be used away from the home's deck(s) or any other wooden structures.
- 3. The area used for the grill set-up and use must be as level as possible.
- 4. Food safety rules must be adhered to.
- 5. Grills must be cleaned after use; no food residue can remain on the grill upon return.
- 6. Grease traps must be emptied and clean before the grill is returned.

Purpose:

To ensure the safety of those using our grills, the Village of Mannville has developed the following Grill Use Policy. Where multiple people intend to be authorized users of the same grill, each person must read and agree to the terms and conditions. Violations of this policy may result in the users being prohibited from using municipal grills. (attached Appendix "A")
