SCHEDULE A – FIRE PITS

DESIGN REGULATIONS

Fire pits and outdoor fireplaces that burn combustible materials shall meet the following minimum requirements:

- a minimum of 3.0 metres (10 feet) clearance shall be maintained from the eaves of a building, property line or combustible material (i.e. decks, trees, fences etc.)
- fire pit and outdoor fireplaces installations shall have a surface not exceeding 1 square metre (10 square feet)
- a spark arrestor mesh screen with a grid spacing of 1.25 centimetres (0.5 inches) or less expanded metal (or equivalent) to contain sparks shall be provided over the fire at all times
- · All fire pit bases shall have a 15 centimetre (6 inch) non-combustible base (i.e. bricks, concrete blocks, cement) in the burning area and the base shall extend a further 30.5 centimetres (12 inches) outside the perimeter of the burning area. Further; a 30.5 centimetre (12 inch) non-combustible (gravel, small rock) perimeter area must be provided around the exterior of the base.
- · All fire pits shall have a solid metal cover that is to be placed on the fire pit when use is finished.

USE REGULATIONS

- 1. A Fire Pit Application, as attached to and forming part of this bylaw, must be completed and submitted to the Village and the fire pit must then be inspected by two (2) members of the Mannville Fire Department. The inspectors must both approve the application by providing two (2) signatures certifying the same on the Fire Pit Application form.
- 2. The use of fire pits within the Village is intended for recreational purposes only.
- 3. The user shall not allow smoke or sparks to create a nuisance or hazard to neighbors or to other properties.
- 4. Only clean seasoned wood that is not contaminated with glue, paint, stain or other preservatives may be used for burning.
- 5. Refuse or waste materials including grass and leaves shall not be burned.
- 6. Large fires or bon fires are not permitted; fires shall not have a flame height of more than 50 centimetres (20 inches) above the fire pit screen surface.
- 6. All fire pit fires must be attended by a competent adult who is suitably equipped to effectively safeguard the fire at all times until the fire is totally extinguished.
