Highlights from the Regular Council Meeting held on June 17, 2025:

- Council provided first reading to 2025-882 Land Use Bylaw Amendment. A Public Hearing has been scheduled to take place on **July 15, 2025 at 6:30 p.m.** in the **Village of Mannville Council Chambers**, in accordance with sections 606, 692 (1)(f) and 216 (4) of the *Municipal Government Act*.
- Council directed Administration to contact the County of Minburn No. 27 regarding the use of the two-way radios, previously used by the Fire Department. Alternatively, in the event that the two-way radios are not available from the County of Minburn No. 27, that Council approve the purchase of two-way radios for the Public Works Department at a cost of \$2,835.80 (GST not Included) with a monthly cost of \$150.99.
- Council endorsed a motion to approve the Road Rehabilitation project, per the quote submitted by Spectre Systems, of Phase 1 (45 Street from 52 Avenue to 53 Avenue) at an estimated cost of \$194,598.50 (GST not included) to be completed by December 31, 2025, and Phase 2 (45 Street from 52 Avenue to 51 Avenue) in the amount of \$67,137.25 (GST not included) to be completed by December 31, 2026. Furthermore, the cost of this project be taken from MSI Capital, CCBF Capital and LGFF Capital Funding.
- Council endorsed a motion approving the appointment of Tracy Stirling as a new member of the Mannville Centennial Library Board.

BYLAW 2025-882 – Land Use Bylaw Amendment

Take notice that Bylaw 2025-882 will provide the following amendment to Land Use Bylaw 2006-734:

- a) Section 7.2– Public Service District (P-1) is revised to add “Child Care Facility” to the list of Discretionary Uses in Section 7.2 (3), in alphabetical order.

A **Public Hearing** will be held to provide an opportunity for members of the public to speak to Council on the proposed bylaw commencing at 6:30 p.m., Tuesday, July 15, 2025, at Council Chambers (Village of Mannville Administration Building 5127-50 Street, Mannville AB). Electronic attendance will also be available via Zoom – connection details will be made available on the Village of Mannville’s website prior to the hearing at www.mannville.com.

Anyone wishing to speak on the above is invited to attend. Written submissions are highly encourage. 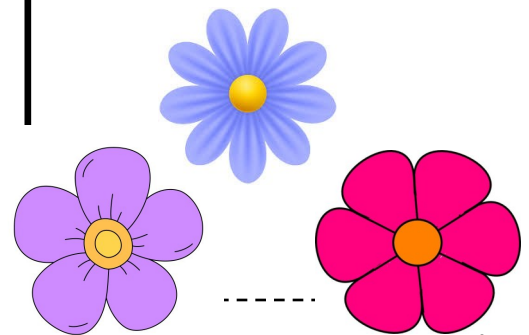
