• Council held a public hearing in Council Chambers, and via Electronic Means, in the Mannville Village Office on Tuesday, July 15, 2025 for Bylaw No. 2025-882 - Amending Land Use Bylaw 2006-734. No Members of the public made representation at the Public Hearing. Therefore, the public hearing was closed at 6:40 p.m.

## Highlights from the Regular Council Meeting held on July 15, 2025:

- Council provided second and third reading to 2025-882 Land Use Bylaw Amendment.
- Council endorsed a motion to approve the Performance Management Policy 1900-25 as amended.
- Council endorsed all three (3) readings on the 2025-883 Assessment Review Board Bylaw.
- Council endorsed a motion to approve MPE Engineering's quote to conduct a Preliminary Site Assessment of hole #7 at the Mannville Riverview Golf Course in relation to the Riverbank Erosion project scheduled for 2026.
- Council endorsed a motion to approve Lloyd's Limb Services Inc. Quote for tree removal and pruning services within the Village of Mannville.
- Council endorsed a motion to refund a Seasonal Campsite Lease, less power usage cost from May 1-June 30, in the amount of \$1,362.00.
- Council endorsed a motion to approve the amendment to the Parks & Campground Policy 7000-03.
- Council endorsed a motion to approve the amended 2025 Capital Budget, for the total amount of \$678,665.
- Council endorsed a motion to refund a Seasonal Campsite Lease, in the amount of \$1,305.03.

#### NOTICE TO LANDOWNERS

#### Unsightly premises

The Village of Mannville would like to remind landowners, that pursuant to community Standards bylaw 2010-764 section 2.2 (h):

No person shall allow the grass or weeds to exceed a height of 15 centimeters (6 inches), unless it forms part of "naturalized Area"; and for greater certainty shall apply to:

- i. Vacant lots within residential areas
- ii. Grass/weeds on any boulevard that lies directly in front or bordering owner's parcel
- iii. Between the boundary of a parcel of land and an adjacent highway, road or alley.
