Highlights from the Regular Council Meeting held on March 18, 2025:

- Council endorsed second and third reading on Parks and Campground Bylaw 2025-878.
- Council approved Parks and Campground Policy 7000-03 with amendments.
- Council approved Golf Course Manager Job Description Policy 1900-24 with amendments.
- Council endorsed a motion to rescind motion #2025.02.18/17. Furthermore, Council endorsed a motion to respectfully decline entering into an agreement with the Board of Buffalo Trail Public Schools for the purpose of conducting the 2025 Election.
- Council endorsed a motion to approve the Master Services Agreement and Statement of Work Agreement, as presented by Circular Materials, in relation to the Extended Producer Responsibility (EPR) Program.
- Council endorsed a motion to approve the proposal to renew the assessment services contract with Wainwright Assessment Group Ltd. for the period of April 1, 2025 to March 31, 2026

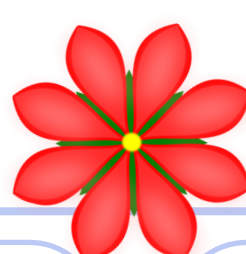

Voter Registration

NEW for 2025 - Municipalities are required to maintain a Permanent Elector Register of residents who are eligible to vote. You must be registered to vote on Election Day.

- ✓ To pre-register or check your registration status, visit the Voterlink website.
- ✓ The County of Minburn, Village of Mannville and Village of Innisfree receive and use their list of eligible voters from Voterlink, so please confirm your information is correct to ensure you are ready to vote.
- ✓ Please note that registering through Voterlink will add you to the Provincial Electors Registry
- ✓ If you are not on the Permanent Electors Registry, you must bring a number of documents on election day to confirm your eligibility to vote.

Permanent Electors Register & Voting Information

At the Polling Station

- If you are already named on the Permanent Electors Register, you must provide **one piece of Government-issued photo ID**, including your full name, current address, and photo.
Please note: **Another elector can no longer vouch for your identity.** You must be able to produce an acceptable form of identification.

If You Are Not Named on the Permanent Electors Register:

- Make a statement confirming your eligibility to vote in the prescribed form.
 - Validate your identity and address of residence by producing one (1) of the following:
 - One piece of **Government-issued photo ID**, including your full name, current address, and photo.
 - One piece of identification authorized under the Election Act (s. 100(2)(b)) that establishes your name and current address of residence.
- A more detailed list of authorized identifications will be provided closer to Election Day.

For Identification Containing a Mailing Address (e.g., PO Box):

- If you registered to vote at your current physical address, you can use your **Driver's License or Identification Card** with your current mailing address.
- If you are not registered to vote or need to register at a new physical address:
 - If you have a **Government of Alberta-issued Driver's License or Motor Vehicle Operator's License**, you do not need additional identification.

If you do **not** have a Government of Alberta-issued license, you will need additional identification to prove your physical address (e.g., legal land description, lot-block-plan, and/or 911 address) prior to voting.

Vouching

- Another elector is only permitted to vouch for **someone's address, not their identity.**
An elector who has been vouched for **cannot** vouch for another.

GARBAGE COLLECTION

Roll-out bins **MUST** be accessible to the garbage truck and all garbage **MUST** be inside the bin.

Please be mindful when disposing of garbage. Although they are "garbage bins", they're meant for regular household garbage **ONLY**. Some items cannot go into the bins such as: large/long items (i.e., lumber, branches, logs, etc.), appliances, car parts, oil, concrete, dirt, propane bottles, etc.

The garbage bin lid must be able to close. **DO NOT** leave any garbage outside OR beside the bin!

Items placed outside or beside the garbage bin will **NOT** be picked up.

Please ensure there are no objects or vehicles parked near, or in the way of the garbage bin.
